From Toy Piano to Carnegie Hall

Silvie Cheng found her vocation at age 4 when she played with a toy keyboard. Music became her passion — a passion that has brought her international acclaim. And the National Arts Centre helped her get there. Each year, the Summer Music Institute (SMI) at the National Arts Centre selects 70 exceptional young artists from around the world for its respected Young Artists Program. Participants receive private instruction, chamber music coaching, and many opportunities to perform. It's an unmissable opportunity to learn from the best in the world — an opportunity that Silvie found tremendously worthwhile.

Matched by Marg Campbell, a committed donor to the NAC and the Summer Music Institute, Silvie attended the SMI with her younger brother Bryan in both 2013 and 2014. These gifted siblings played as a piano-cello duo and in other chamber ensembles. "Being able to meet and make music with some of the world's most talented young musicians," shares Silvie, "was simply inspiring."

Silvie was a natural for the Summer Music Institute. After graduating from Ottawa's Lisgar Collegiate Institute, she went on to obtain her Bachelor of Music and Master of Music degrees from the Manhattan School Cont'd on Page 4

Born and raised in Ottawa, Marg studied physics and chemistry at Queen's and biophysics at McMaster. She became a teacher and spent her entire career at Ottawa's Gloucester High School, retiring in 2003.

of Music in New York City. She graduated with highest honours, receiving the Roy M. Rubinstein Award for "exceptional promise in piano performance". In addition to her performing, Silvie is now a teaching-artist in the school's Distance Learning program.

Her accomplishments would leave most of us in awe. She has won top prizes at Canadian and international competitions. She has performed at New York's Carnegie Hall four times since 2011 both as a soloist and chamber musician and has presented recitals and concerts across North America, Europe and Asia. She is the pianist of the Cheng² Duo alongside her cellist brother, Bryan, with whom she has been making music for the past 13 years. This coming year the duo will be recording their debut CD in Berlin, Germany, and is scheduled to give a 13-city recital tour across China, followed by a two-week recital tour in Atlantic Canada. Silvie is just 24 years old.

Her association with the National Arts Centre goes back many years. Growing up in Ottawa, she attended many concerts at the NAC with her family. She was also mentored and coached by National Arts Centre Orchestra musicians and shared stages with them at charity concerts. Attending the Summer Music Institute was yet another happy link in her relationship with the NAC, one that enabled her to grow as a musician.
